

PARHAM RECEIVES JAMES PARTRIDGE AWARD

Loretta Parham has been named the 2018 recipient of the James Partridge Outstanding African American Information Professional Award, presented by the College of Information Studies at the University of Maryland in partnership with Citizens for Maryland Libraries.

Ms. Parham is the CEO & Library Director of the Robert W. Woodruff Library of the Atlanta University Center, Inc., an independent entity operating as the single library shared by its four member institutions—Clark Atlanta University, the Interdenominational Theological Center, Morehouse College and Spelman College. Under her leadership, the library was awarded the Association of College & Research Libraries (ACRL) 2016 Excellence in Academic Libraries Award.

With more than 30 years in the profession her experience includes: Director of the Hampton University Library, Deputy Director of the Carnegie Library of Pittsburgh, Pa., District Chief of the Chicago Public Library (CPL) and other professional positions with the Chicago Public Schools and the City Colleges of Chicago.

Ms. Parham holds a Master of Library Science degree from the University of Michigan-Ann Arbor and a Bachelor of Science degree in Communications from Southern Illinois University-Carbondale.

Call for CML Award Nominations

Each year CML presents three prestigious awards. Nominations are now being sought for 2019 award recipients for:

- The Marion Satterthwaite Award in recognition of outstanding advocacy efforts for libraries.
- The Davis McCarn Award for innovative use of technology to enhance library service.
- The Outstanding Library Employee (or Team) Award to recognize a library staff member(s) who has made exceptional contributions to public service.

Deadline for award nominations is January 10. Please submit a nomination that includes name of the award, name of nominee, and a statement of up to 500 words describing the achievements of the nominee that has led to improving library service in Maryland. Nominations should be sent to the attention of the CML Awards Committee via email at *cml@ citizensformarylandlibraries.org*.

Award recipients receive a framed certificate and a check for \$100. The awards are presented at the MLA Annual Conference. CML will also award one night free at the Conference hotel (if reimbursement is not provided by another organization) and tickets for two for a Conference dinner/banquet (if reimbursement is not provided by another organization). The award recipients will also be announced at the CML Annual Meeting and publicized in the CML newsletter. The Outstanding Employee Award is also announced at the Maryland Legislative Day Reception in Annapolis. CML will also present the award at a recipient's local county trustee/board meeting or reception.

In 2018, awards were presented as follows:

Sharon Maneki received the Marion Satterthwaite Award for outstanding advocacy for her tireless work as a member of the Friends of the Maryland State Library for the Blind and Physically Handicapped.

Liz Sundermann received the Davis McCarn Award for her role in bringing new technology and computer science educational experiences to thousands of library customers in Maryland.

The Polaris Implementation Team of the Eastern Shore Regional Library, Inc. received the Outstanding Employee/Team Award for the successful implementation of the Polaris ILS in all eight counties served by ESRL.

United for Libraries Partners on "Summer Scares"

The Horror Writers Association (HWA) is developing a "Summer Scares" reading program that will provide libraries and schools with an annual list of recommended horror titles for adult, young adult (teen), and middle grade readers. The goal is to introduce new authors and help librarians start conversations with readers that will extend beyond the books from each list and promote reading for years to come.

HWA is partnering with United for Libraries, Book Riot, and Library Journal/School Library Journal on "Summer Scares." Award-winning author Grady Hendrix and a committee of four librarians will be selecting three recommended fiction titles in each of three reading levels— Middle Grade, Teen, and Adult— for a total of nine "Summer Scares" selections. The goal of the program is to encourage a national conversation about the entire horror genre, across all age levels, at libraries all over the country and ultimately get more adults, teens, and children interested in reading. Official "Summer Scares" designated authors will also be making themselves available to appear, either virtually or in person, at public and school libraries all over the country, for free.

Federal Spending Bill Includes Funding for Libraries

On Friday, September 28, the POTUS signed a spending bill (HR 6157) that includes:

- \$242 million for the Institute for Museums and Libraries, a \$2 million increase
- \$189.3 million for the Library Services and Technology Act, which is level funding
- \$27 million for Innovative Approaches to Literacy (IAL), which is level funding. IAL supports high-quality programs designed to develop and improve literacy skills for children and students from birth through 12th grade in high-need local educational agencies.

On Tuesday, October 30, an enthusiastic crowd gathered in Hancock, Maryland to celebrate the opening of the new Veterans Memorial Branch. Mary Baykan, executive director of Washington County Free Library said, "It's an exciting day for the county, for the community and for the library system. We are going to be able to provide 21st-century library services and resources to the children and families of Hancock, and we are overjoyed that this day has come."

The new 8,134 SF library replaces the old 1,000 SF library. The new library was built at a cost of just under \$3 million.

Hancock Mayor, Ralph Salvagno praised the efforts of all those involved in the making the library a reality and noted, "But I think most importantly, what this library represents to me is 'equality,' because no matter who you are, no matter what walk of life, what age, race, sex, religion, creed, whatever, those doors are open to you," Salvagno said, gesturing to the building's entrance. "And that is what really makes this a public library."


